CRITERIA FOR TEAM CONTROL IN THE FRONT COURT

1

Player touching frontcourt with both feet while holding, catching or dribbling the ball in frontcourt



2

Ball is passed between players of the same team in frontcourt





CRITERIA FOR BALL RETURNED TO BACKCOURT

1

Team control in the frontcourt

2

Same team player is **last to touch** the ball in the frontcourt

3

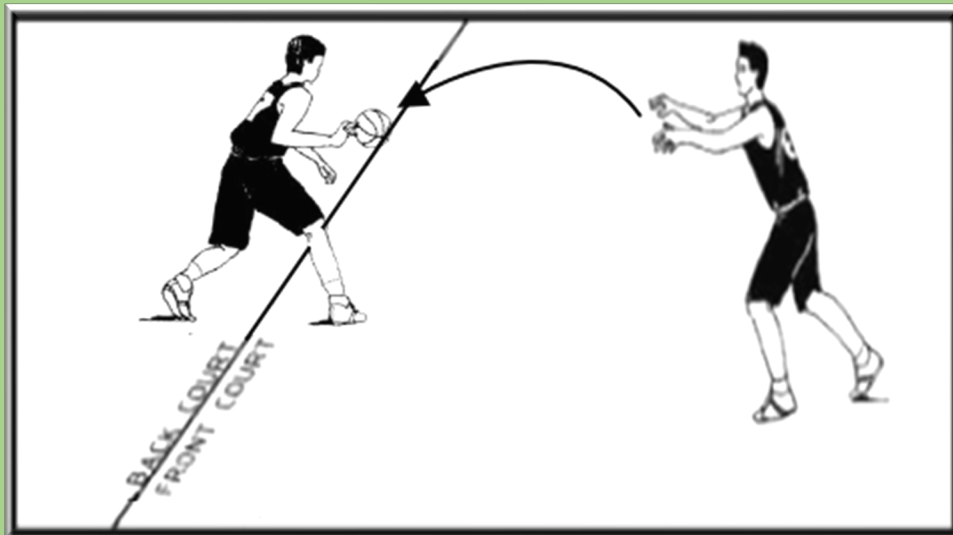
Same team player is **first to touch** the ball in the backcourt

- Who has part of his body in contact with the backcourt **or**
- After ball has touched the backcourt of that team

Also applies to all throw-ins from the team's frontcourt

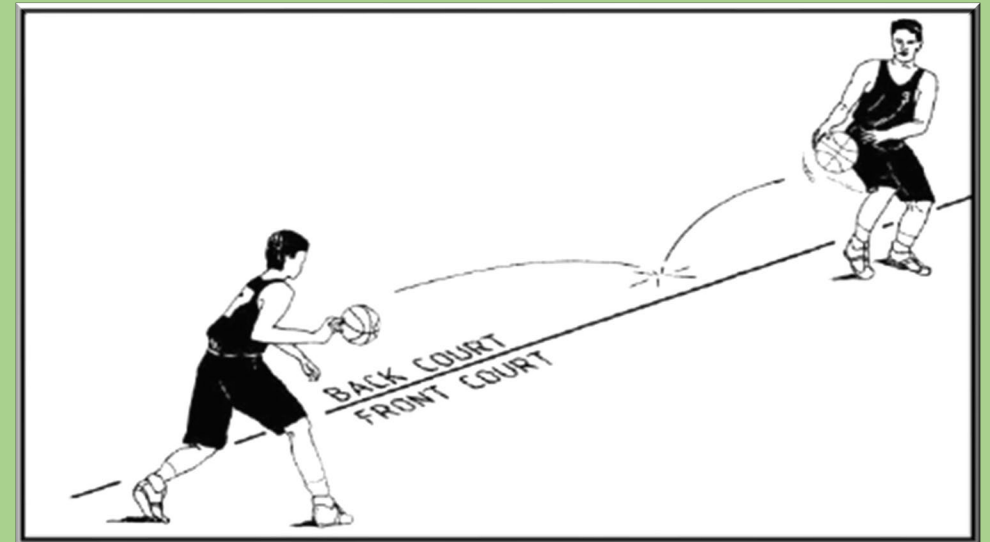

VIOLATION



Same team player who has part of his body in contact with the backcourt is first to touch

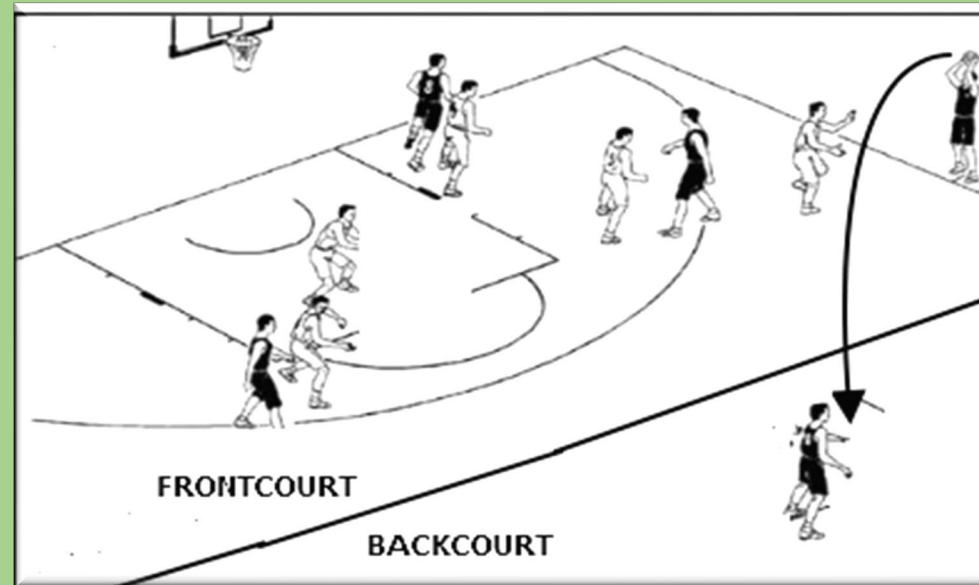
VIOLATION



Same team player is first to touch the ball after it has touched the backcourt of that team

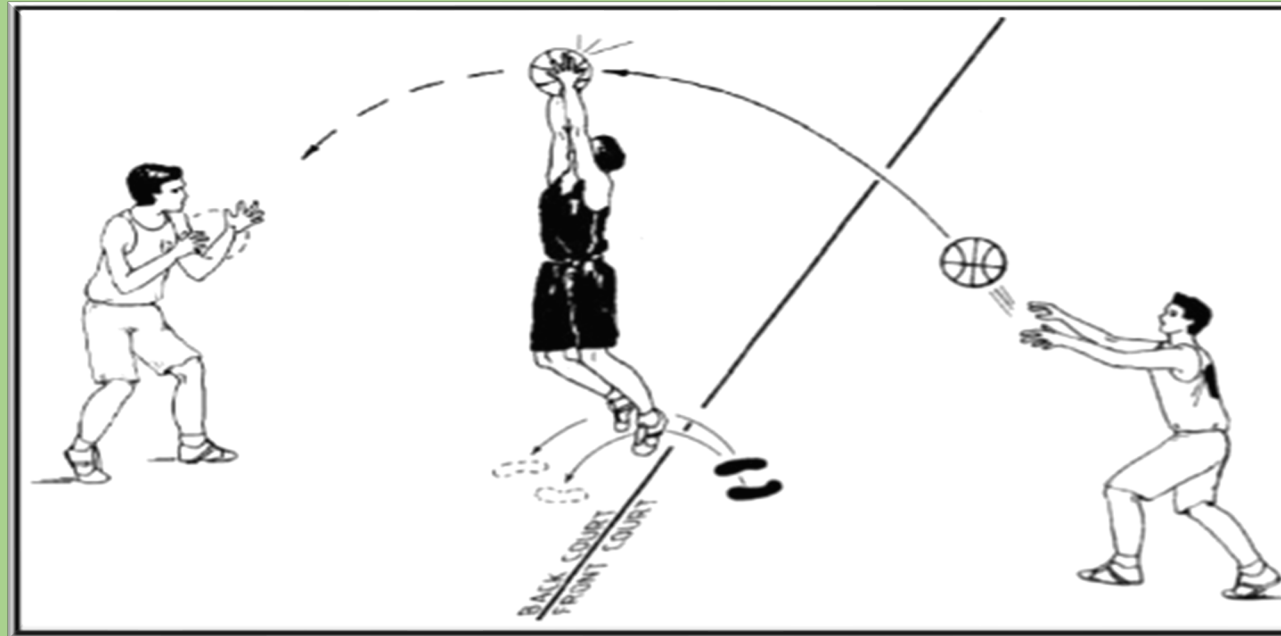

VIOLATION



**Thrower in the frontcourt passes
to same team in the backcourt**

EXCEPTION



Defensive player jumps from his frontcourt; **establishes new team control** while airborne and lands in his backcourt.



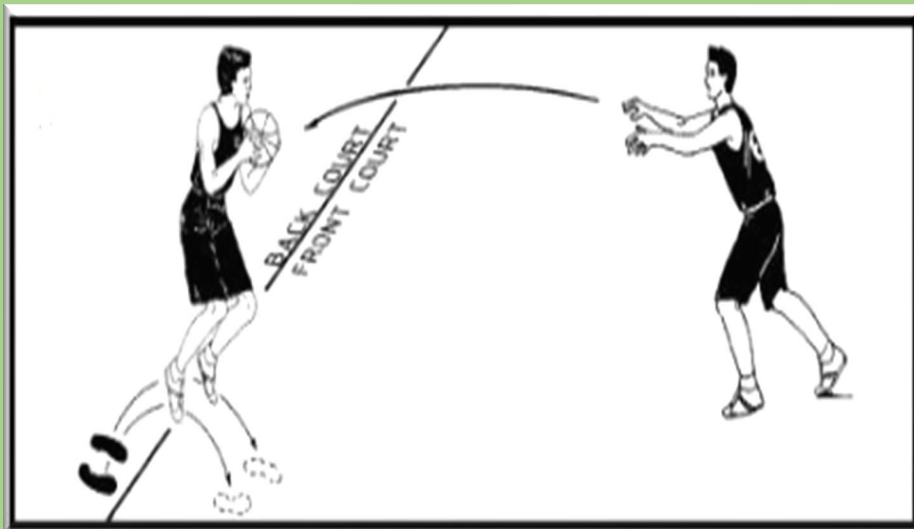
PENALTY

Throw-in to opponents in the frontcourt at the **point of infraction** (*the place where the same team was the first to touch the ball in its backcourt*) with 14 seconds on the shot clock

NO.	LOCATION OF THE PLAYER IN THE BACKCOURT	THROW-IN PLACE
1	Straddling the centre line	Near the centre line
2	Both feet in the backcourt near centre line	Near the centre line
3	Any other place in the backcourt	Nearest to the infraction

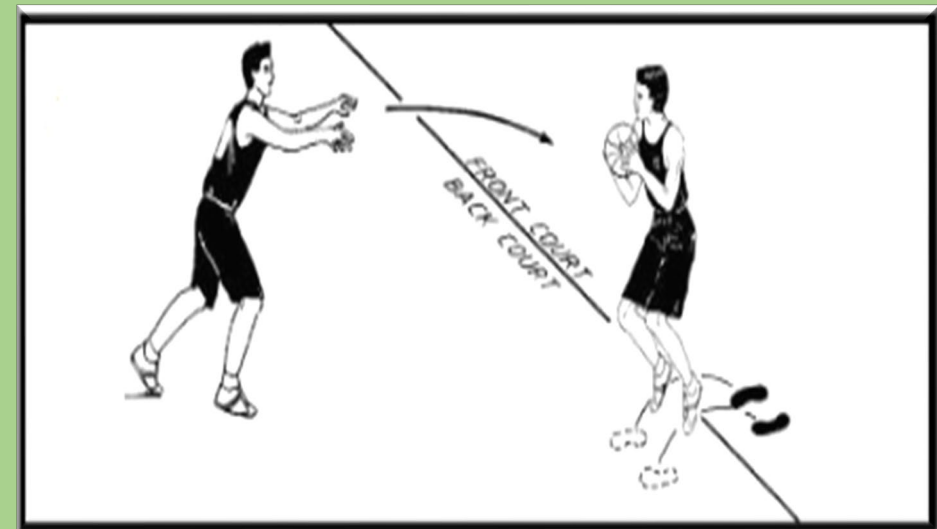
GAME SITUATIONS

VIOLATION



Same team player is first to touch in the backcourt

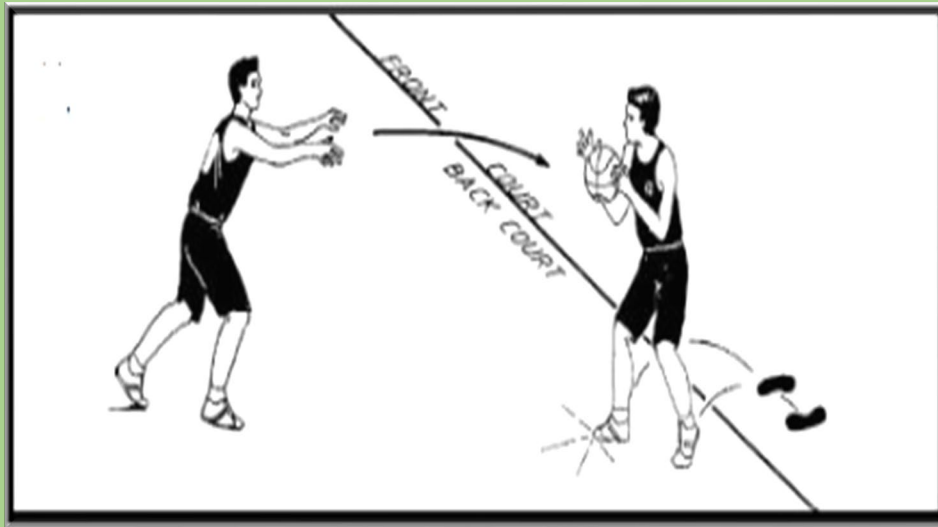
VIOLATION



Same team player jumping from frontcourt establishes team control while airborne; is the last to touch the ball in frontcourt and also the first to touch the ball in backcourt

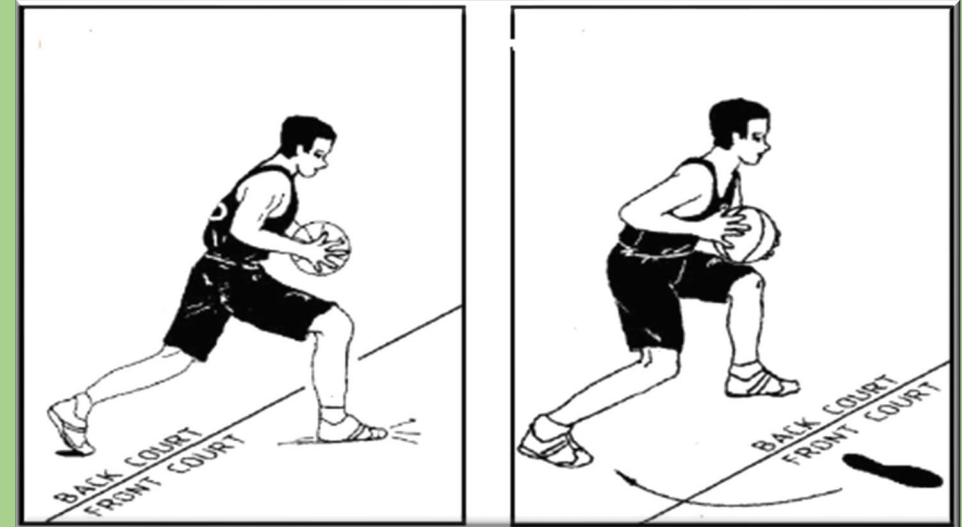
GAME SITUATIONS

LEGAL



Same team player jumping from frontcourt establishes team control after landing with both or one feet in the backcourt

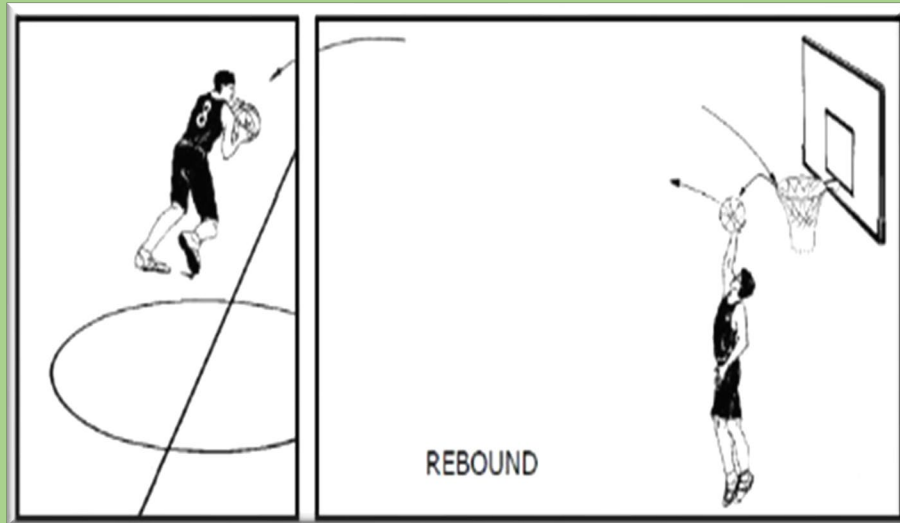
LEGAL



Both feet of the player with the ball has not touched the frontcourt; team control not established in frontcourt

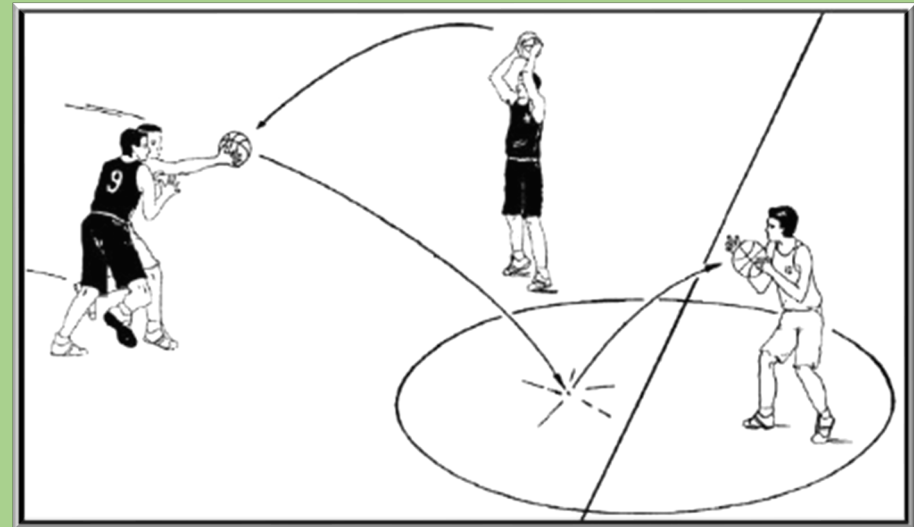

Player taps the ball on a rebound and is collected by same team player in team's backcourt

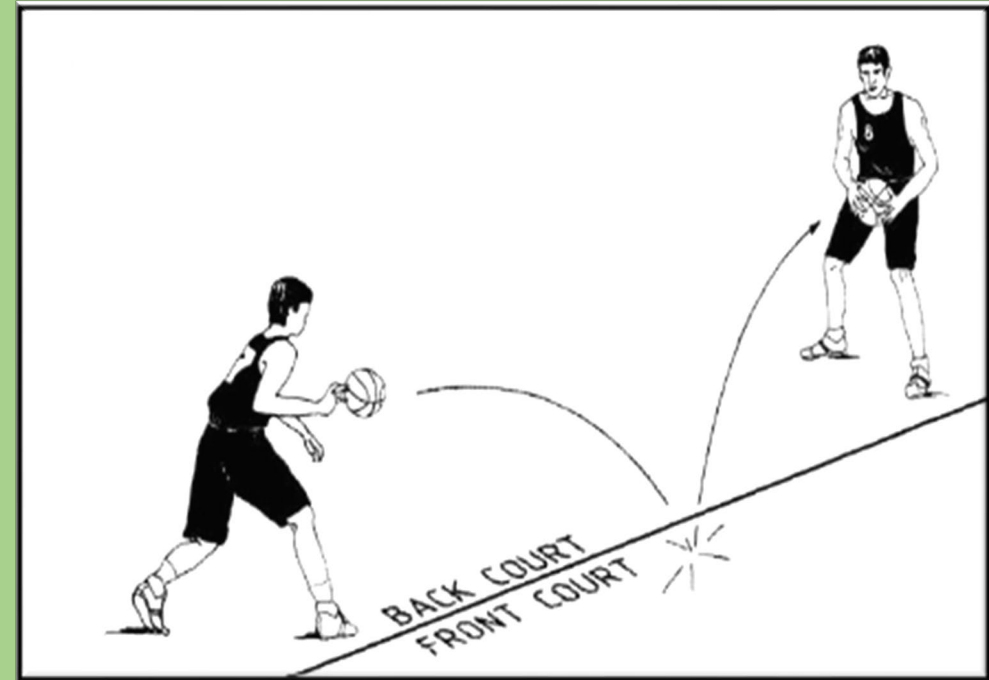
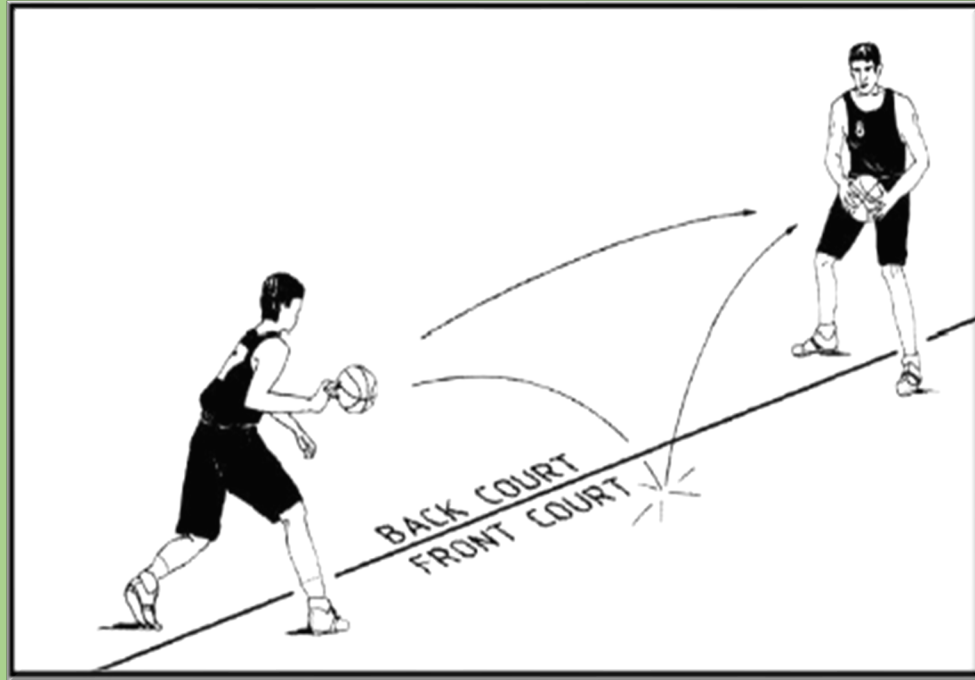


Defensive player in his frontcourt deflects a pass or taps the ball to his teammate in the backcourt

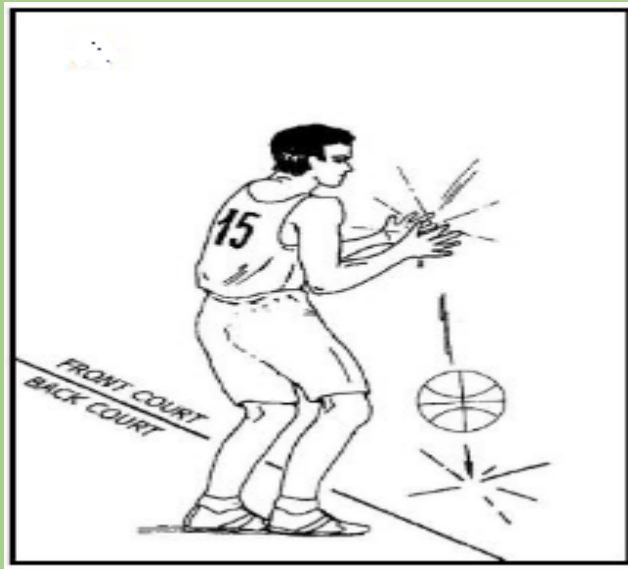

Player in the backcourt fumbles the ball which touches the frontcourt and is caught again by the same player

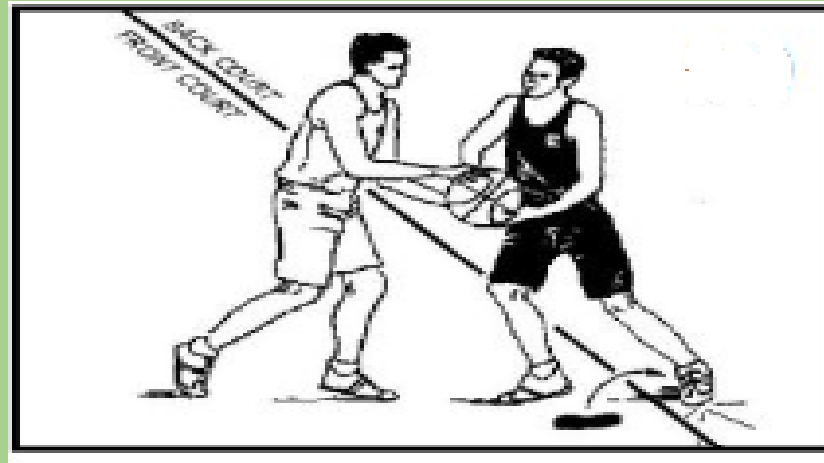
VIOLATION



Player in the frontcourt fumbles the ball which touches the backcourt and is caught again by the same player

JUMP BALL SITUATION



Two opponents are holding the ball in the frontcourt of black team when black team player steps on to his backcourt.
